Electrolux is a leading global appliance company that has shaped living for the better for more than 100 years. Based in Stockholm, Sweden, with a workforce of approximately 51,000 selling around 60 million household products in around 120 markets every year. Electrolux is a true sustainability leader, one of the first 100 companies in the world to establish science-based goals for reducing greenhouse gas (GHG) emissions.

In a bid to streamline their IT Asset Disposition (ITAD) program and contribute to their sustainability goals, Electrolux transitioned from utilizing two local providers to engaging a single global vendor. Electrolux recognized the potential advantage of consolidating ITAD vendors. By streamlining to a single global service provider, they could achieve benefits such as improved value recovery, better efficiency, quality control and enhanced sustainability benefits.

### Setting Clear Objectives

Electrolux wanted to identify a solution that would contribute to their corporate objectives of achieving climate neutrality by 2030, implementing high-level security measures, establishing efficient global operations, and maintaining Electrolux's esteemed reputation. They prioritized selecting a vendor with a strong global presence capable of meeting Electrolux's requirements for managing used IT equipment through resale, refurbishment, or recycling, while also focusing on security and environmental considerations.

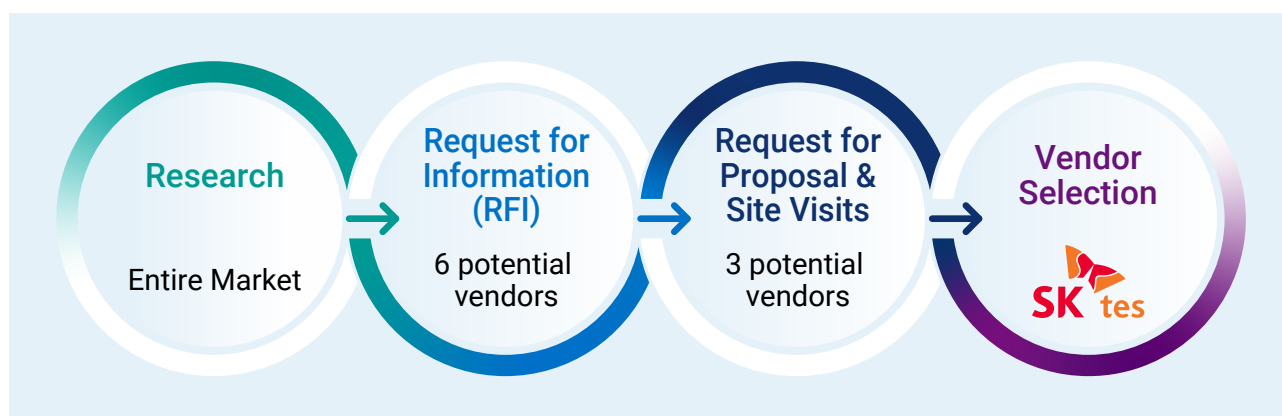
### Selecting the Right Partner

The decision-making process undertaken by Electrolux was carefully considered and thorough. It started with referencing [Gartner's Market Guide for IT Asset Disposition](#)<sup>1</sup>, which provided valuable insights and benchmarks about the industry as well as advice on considerations when selecting a global ITAD partner. Electrolux reviewed and analysed their existing ITAD programs to ensure a complete understanding of the ITAD business, their organizational needs, and potential risks and opportunities.

Electrolux embarked on an evaluation process by issuing a Request for Information (RFI) which was sent to six potential vendors that had been identified during the initial research phase. Following the RFI, three vendors who met Electrolux's criteria were invited to participate in a comprehensive Request for Proposal (RFP) process.

The RFP process was a critical stage in Electrolux's vendor selection. By inviting vendors who met specific criteria the RFP allowed for a more in-depth evaluation of the vendor's capabilities and involved on-site visits to their facilities. These visits provided insights into the vendors' capabilities and their company culture and working environment. Electrolux knew that the on-site visits would play a crucial role in the decision-making process, providing valuable insights that could not be fully captured through written proposals or virtual meetings.

Meeting the people who would be involved in the partnership allowed for an understanding of the team dynamics and observing the operation process firsthand gave Electrolux a real feel for how well the vendors aligned with their standards and values. This hand-on approach enabled Electrolux to confidently make an informed decision based on direct observation and interaction with the potential vendors.
